If you own income producing property, you must file a Real Property Income and Expense Statement or a Claim of Exclusion unless you are exempt by law. The deadline to file is June 1, 2015. Failure to file will result in penalties and interest, which will become a lien on your property if they go unpaid. To see if you are exempt from this requirement and to learn more, please visit nyc.gov/rpie.

You are entitled to protest the Emergency Repair Charge and the Alternative Enforcement Program charge by filing an objection in writing with the Department of Housing Preservation and Development (HPD), but any such objection must be filed prior to the date that the charge will become due and payable, as provided in NYC Housing Maintenance Code section 27-2144. For information on filing an objection, please call HPD at 212-863-6020 or email HPD at hpderp@hpdnyc.gov. The charge is enforced as a tax lien on real property under article 8 of subchapter 5 of the NYC Housing Maintenance Code.

## Home banking payment instructions:

- 1. Log into your bank or online bill pay website
- 2. Add the new payee: NYC DOF Property Tax. Enter your account number, which is your boro, block and lot, as it appears here: 2-03108-0004. You may also need to enter the address for the Department of Finance. The address is P.O. Box 680, Newark, NJ 07101-0680.
- 3. Schedule your online payment using your checking or savings account
