- The Department of Finance estimates that as of January 5, 2012, the market value for this property is \$207,000. Finance will use this market value to determine your property taxes starting July 1, 2012.
- Finance estimated your property's market value using the income approach.

Factors Used By Finance To Determine Market Value:

- Building Gross Square Footage: We estimated building gross square footage at 2,920.
- Gross Income: We estimated gross income at \$40,150.
- Expenses: We estimated expenses at \$8,380.
- Net Operating Income: We subtracted estimated expenses from estimated gross income, resulting in a net operating income of \$31,770.
- Base Cap Rate: We used a capitalization rate of 10.750% which is Finance's estimate of the rate of return that an ordinary investor would expect on their investment in this type of property.
- Overall Cap Rate: We added an effective tax rate of 4.568% to account for taxes due. Added together your overall capitalization rate is 15.318%.
