Important Information

If you disagree with your property value, you may appeal to the NYC Tax Commission no later than March 3, 2014. Your Assessed Value will not be reduced unless you can demonstrate that the value of your property is less than your Effective Market Value of \$214,271.

Real Property Income and Expense

If you own income producing property, you must file a Real Property Income and Expense Statement or a Claim of Exclusion unless you are exempt by law. The deadline to file is June 2, 2014. The Department of Finance estimates that as of January 5, 2014, the market value for this property is \$683,000. Finance will use this market value to determine your property taxes starting July 1, 2014.

Finance estimated your property's market value using the income approach.

Factors Used By Finance To Determine Market Value:

- Building Gross Square Footage: We estimated building gross square footage at 4,290.
- Gross Income: We estimated gross income at \$73,874.
- Multiplier: We used a gross income multiplier of 9.250 which is our estimate of the relationship between the property's income and the property's market value.

Under State law, your assessed value cannot increase more than eight percent per year and 30 percent in five years unless you make a physical change to your property. Since you made a physical change to your property, your assessment was probably increased more than eight percent this year.
